- "P" - A use that is permitted under this Scheme.
- "AA" - A use that is not permitted unless approval is granted by the Council.
- "IP" - A use that is not permitted unless such use is incidental to the predominant use as decided and approved by the Council.
- "X" - A use that is not permitted.
