
BOARD NOMINATION Alistair Scott

Alistair has extensive experience in public sector management and governance at a senior level, both in the Department of Premier and Cabinet (DPAC) as Director of Local Government and in the Department of Primary Industries, Parks, Water and Environment (DPIPWE – now Natural Resources and Environment) as a senior manager in natural and cultural heritage. He also has experience as a board member and has recently completed a PhD in Tasmanian history at the University of Tasmania.

Alistair has previously served on a number of boards including the Local Government Board, the Tasmanian Libraries Advisory Board and the management boards for both NRM North and NRM South; is currently a director of Cricket North and has undertaken governance training (with NRM South).

Alistair has experience as a committee member for member-based organisations including the Hobart Jazz Club, the Tasmanian Cricket Umpires and Scorers Association and Cricket North. Among his early roles, he held the position of communications manager with DPIPWE.

She has been a member of the Board of UN Women Australia and is currently a Board member of the Queen Victoria Museum and Art Gallery Foundation and Deputy Chair of the National Trust Tasmania.

With a long history in heritage, David is currently a member of the Heritage Sector Focus Group – Funding Options, formed July 2023 by Heritage Tasmania. His past memberships include the Southern Midlands Council "Centre for Heritage Conservation & Restoration" advisory committee 2009 - 2013; the Ipswich City Council Heritage Consultative Committee, Queensland (2005 to 2010); the Ipswich City Council Heritage Consultative Committee Development Assessment Subcommittee and the Queensland Heritage Council.

David has considerable National Trust membership, as a member of the Natural Trust Queensland since January 1987, a current National Trust Tasmania member and an active member of the Ipswich Branch, National Trust of Queensland, from 1987. David was chairperson of the Ipswich Branch of the National Trust from 2003 to 2006.

His Heritage awards are numerous winning excellence awards for 'Gosford', 'Brighton House' and 'Kerwick House' most notably the 1999 National Trust, Queensland, John Herbert Award for Excellence in Heritage Conservation Works, or Action for the Conservation of "Gosford".

In April 2006, David and Anne Kernke purchased 'Shene Estate', where they created and operated Shene Distillery which has just sold to Lark.

Well known for the restoration of their historic property - Hollow Tree House (historically known as Strathborough), Harriett England and her husband Richard have lived in Tasmania permanently for the last six years.

Their work on the house has been well documented in various publications, books and television programs and the project won both the 2020 Tasmanian Architecture Awards - Heritage Architecture Award and the National Architecture Awards -Lachlan Macquarie Award for Heritage Architecture. Future plans are to dedicate Hollow Tree House, and the landscape it sits in, to sharing and celebrating the culture and artwork of Australia's First Nations people.

Harriett is a member of many institutions including the NGA, NGV, MCA and AGSA contemporary collectors group. She is also a member of the TMAG Foundation, where she recently joined the board, the Australian Garden History Society and the Tasmanian Symphony Orchestra.

Harriet would like to explore ideas for fundraising to support the protection and maintenance of Tasmania's heritage. She has a keen sense of the need for fundraising, attracting new membership, and to increase knowledge of the Trust's work, and would like to work towards encouraging a different demographic and inspiring younger people to become involved.

An inclusive leader and tourism operator with an appreciation for Tasmania's heritage, Kerry Houston has demonstrated management, marketing, human resource, leadership, and communication skills along side a passion for reimagining heritage buildings and 'telling their story.' Kerry is skilled in corporate leadership, has a commitment to heritage preservation and understands small business in the tourism arena. From steering payroll and human resources for a significant organization to thriving small business ownership, her journey embodies strategic acumen, community engagement, and a passion for elevating heritage tourism experiences.

Growing up in regional Victoria, Kerry is now passionately Tasmanian. She has spent over a decade based in Hobart, and has spent the last five years in Stanley on the far north west coast bringing strong regional perspective and insights from the north of the State. As owner operator of the ship inn Stanley, she renovated the heritage listed property which has now received national and state tourism awards.

As Vice President of the Circular Head Tourism Association, Kerry's contributions led to Stanley's victory in the Top Tourism Town competition. Who can vote?

To be eligible to vote in the 2023 election, you must be a current financial member of the NTT at the time and date appointed for the close of nominations on 31 August 2023.

VOTING AND SELECTION CRITERIA

Selection Criteria

The Trust is committed to maintaining a skills-based Board; to gender equality; and to regional representation. It has considered the expertise of current Board members as well as future needs. To ensure that the Trust can maintain its substantive agenda for sustainability and capacity building, the Board has identified the following priority skills and experience it is seeking from new members:

- 1. Strong experience in financial and risk management
- 2. Experience in governance in the notfor-profit sector, preferably as a director
- 3. Strong analytical skills to facilitate critical review of the organisation's strategies and programs
- 4. Experience in small business and the tourism sector
- 5. Experience in a member-based organisation, community engagement and outreach



How many vacancies are there?

There are currently three vacancies for elected Board Members.

The Role of the Board

The Board operates in accordance with the National Trust Act 2006. It has six members, including a Chairperson, who each serve three year terms, and the Managing Director.

Three members are elected by the membership of the Trust and three are appointed by the Minister for Heritage. A director may be appointed, reappointed, elected or re-elected to the Board, but must not serve as a director for more than two consecutive terms.

The role of the Board is to develop and monitor the overall strategic direction of the organisation and to provide governance and compliance oversight of its activities.

The Board is committed to implementing a strategic and sustainable vision for the NTT, its properties, collections, landscapes, gardens, and programs.
