ARCHITECTURE AND BUILDING CONSERVATION

Conservation or restoration works to existing heritage listed buildings, new or adapted buildings, including small projects. Conservation and Heritage Management Plans, heritage reports and planning documents are also eligible in this category.

WINNER

West Block Renovation - Oceana Property and Precept Property Partners

The project involved the major conservation and modernisation of this significant building delivered to a high environmental and quality standard whilst retaining its significant heritage fabric and setting. It is an important example of adaptive reuse and retention of embodied energy that demonstrates how buildings can be sensitively adapted to meet contemporary requirements.

The sign is the outcome of a long collaboration between Traditional Custodians, landholders and community groups, showing respect and acknowledgement for living Aboriginal culture. The efforts of local advocates to protect remnant vegetation and culturally modified trees, with their heritage dimensions, for future generations in the face of potential construction impacts is commendable.
